

Privacy policy

This Privacy Policy for Personal Information (hereinafter - the Policy) applies to all information that a legal body IP Kardynov Ivan Alexandrovich (PGRI: 314524910100019, TIN: 524911692021, registration address: 606034, Nizhny Novgorod Region, Dzerzhinsk, Stroiteley St., 9B-83) and / or its affiliates may get about the user while using the site <http://nndivo.ru/>.

Using the site <http://nndivo.ru/> means the unconditional consent of the user to this Policy and the personal processing conditions specified in it; in case of disagreement with these conditions, the user must refrain from using this resource.

1. Personal information of the users that the site <http://nndivo.ru/> receives and processes

1.1. As part of this Policy, "user personal information" means:

1.1.1. Personal information that a user provides about himself / herself when leaving a request, making a purchase, registering (creating an account) or in another process of using the site.

1.1.2 Data that is automatically transmitted by the site <http://nndivo.ru/> in the process of using it using the software installed on the user's device, including the IP address, information from the cookie, information about the user's browser (or another program through which access to the site), access time, the address of the requested page.

1.3. The site generally does not check the accuracy of personal information provided by users, and does not monitor their capacity. However, the site <http://nndivo.ru/> assumes that the user provides reliable and sufficient personal information on the issues proposed in the forms of this resource, and keeps this information up to date.

2. Purpose of the collection and processing of personal information of users

3 Terms of processing personal user information and its transfer to third parties
